From the above, it is certified that the fire fighting scheme is as per Part-IV of NBC 1983 revised from time to time. Therefore, it is recommended that Fire Fighting Scheme may be approved subject to following conditions:-

- 01. The proposed Fire Fighting Scheme is approved as submitted in the building plan subject to the approval of building plan by the competent authority.
- 02. The approval of fire scheme by the Fire Department doesn't absolve the Owner/Occupier from his responsibility from all consequences, in case of fire occurred due to any deficiencies or anything left out in the scheme submitted to the owner/occupier.

- 03. Overhead & underground water tanks provided for firefighting shall be so constructed in such a way that the domestic water tank shall be filled from
- 04. As soon as the installations of fire fighting arrangements are completed, the same may be got inspected/ tested and clearance should be obtained from Fire
- 05. If the Infringements of Byelaws remains un-noticed, the Authority reserves the right to amend the Plans/Fire Safety Scheme as and when any such Infringements comes to notice after giving an opportunity of being heard and the Authority shall stand Indemnified against any claim on this account.
- 06. The staircase shall be made with the specified material enabling it non-slippery.
- 07. If the gap between ceiling and false ceiling is more than 800 mm, upright sprinkler and detectors above false ceiling & pendent sprinkler below false ceiling shall be installed in the building.
- 08. In case there is any addition/alteration in the construction beyond permissible limit under the Haryana Building Code, 2017, (to be verified by concerned Building Sanctioning Authority), the Fire Fighting Scheme shall cease to exist and the owner/occupier shall apply for approval of revised Fire Fighting Scheme as per the provision of section 18 of Act 2022.
- 09. The approval of fire scheme shall never be treated in any case for regularization of unauthorized construction
- 10. The approval of firefighting scheme is valid for a period of two years for the building falling under clause (b) of sub section (2) of section 18 of Act, 2022 and for a period of 5 years for a building falling under clause (a) of sub section (2) of section 18 of Act, 2022.

It is also mentioned that the Fire Fighting system is found as per guidelines of Part-IV of National Building Code, 1983 revised from time to time and Act, 2022, the case is fit
